Notice is hereby given that the 35th Annual General Meeting (AGM) of S R Industries Ltd (the "Company") will be held on Thursday, 21st August 2025, at 12:30 PM, at 5th floor, Plot Number 2, Sahibzada Ajit Singh Nagar, Sector 67 Road, Sas Nagar-160055 to transact the business as mentioned in the Notice of AGM. The Company was under the Corporate Insolvency Resolution Process (CIRP) and the resolution plan was approved as per the order dated 01st July 2025 of the Hon'ble National Company Law Tribunal, Chandigarh Bench. Consequently, the register of members/record of depositors is not up to date. The existing ISIN (INE329C01011) has been suspended, and a new ISIN (INE329C01029) has been issued by the depository. However, as the listing approval from BSE is still pending, the new ISIN has not yet been activated. The Company is currently undergoing rehabilitation in accordance with the approved resolution plan. Pursuant to this plan, the Company has allotted 1,96,73,500 equity shares. An application for the listing of these shares has been submitted to BSE Ltd. and is currently awaiting approval.

As of date, the Promoters Group, i.e., Bazel International Limited along with its Associates, hold 95% of the Company's shareholding and are the majority shareholders, while the remaining 5% is held by the public. The Company has restructured the share capital in coordination with the RTA and accordingly Return of allotment has been duly filed with Registrar of Companies. Since the Company has not received Listing Approval from BSE, new Promoters were unable to credit their equity shares. Old shareholders are still reflecting on RTA's data. Consequently, the register of members is not updated as required, and the Company is unable to send the AGM notice via email. Share transfer and trading are suspended due to the suspension of the ISIN.

Further, notice is hereby given pursuant to Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, that:

- The trading of the equity shares of the Company is suspended due to corporate action, and the application for re-listing is pending with BSE Ltd. Since the equity shares are not yet credited to the demat accounts of the respective shareholders, the Company is unable to issue notice to each shareholder individually. Accordingly, the facility for voting through remote e-voting is not provided. Members/proxies attending the meeting can cast their votes through ballot paper at the time of the AGM.
- The Notice of AGM and the Annual Report for the financial year 2024-25 will also be available on the Company's website at <https://www.srfotwears.co.in/> and on BSE Ltd. at www.bseindia.com.
- All shareholders attending the AGM are required to carry identity proof along with address proof such as Aadhaar Card, Passport, Voter ID, or any other government-issued ID card.
- In view of the circumstances, the Company is unable to send individual notices to shareholders regarding the forthcoming AGM. To ensure compliance with the Companies Act, 2013, the Company is publishing the notice in Financial Express (in English) and Jansatta (in Hindi), which shall be deemed sufficient notice to all eligible shareholders.
- Attention is drawn to the SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/PCIR/2023/61 dated 16th March 2023, which mandates all shareholders holding shares in physical form to update their PAN, KYC, Nomination details, Bank details, contact details, and Specimen Signature. It is also mandatory to link PAN with Aadhar.

Since it has already been stated that the Company is unable to issue the notice to all its members, in this situation and for compliance purposes, the Company is publishing the notice of the 35th AGM in the newspaper. This publication of the notice shall be deemed as sufficient delivery of the AGM notice to all members of the Company.
